       **Beginner A, Beginner B**

I have earned less than \$500 lifetime earnings in any type or class of reining competitions at the start of the year.

       **Beginner Horse Open**

The horse which I have entered in this class has earned less than \$500 lifetime earnings in any type or class of reining competitions at the start of the year regardless of ownership.

       **Rookie**

I meet the Rookie criteria as set out in the current NRHA Rule Book.

       **Novice Horse – Open & Non Pro**

The horse and rider meet the criteria as set out in the current NRHA Rule Book

       **Ltd. Non Pro**

I meet the Ltd. Non Pro criteria as set out in the current NRHA Rule Book.

       **Non Pro**

I meet the Non Pro criteria as set out in the current NRHA Rule Book.

       **Ltd. Open**

I meet the Ltd. Open criteria as set out in the current NRHA Rule Book.
