It is hereby declared and agreed upon between Arlene Omelchuk and Three Hills Ranch / Doug and Lynette Mills and Erin Valley Riding Stables And

- 1. I am aware that horseback riding contains inherent risks of injury and/or death to me personally, to my horses, and damage to my equipment caused by accident, my own negligence or the negligence of others. Riding is hazardous because, even if the rider is knowledgeable, horses sometime act unpredictably to environmental changes, or unfamiliar sights or noises. Accidents can cause severe injury and/or death to the horse and/or rider. The failure by the rider to adjust equipment properly can result in injury and/or death. When riding in groups, the rider and/or horse may suffer injury and/or death because of another rider and/or horse.
- 2. Knowing these facts, I nevertheless, in consideration of the acceptance of this agreement by Arlene Omelchuk and Three Hills Ranch, Doug and Lynette Mills and Erin Valley Riding Stables, Clinic Sponsors and Property Owners, hereby for myself, my heirs, executors and administrators, assume the risk of these and similar dangers and waive any claims against, release and forever discharge Arlene Omelchuk and Three Hills Ranch and their employees, agents, volunteers and representatives (and their heirs, executors, administrators and assigns) from any and all right, claim or liability for damages or for any and all injuries and/or death that might result of, the use of the facilities, proper, and horses for riding, boarding or instruction and all related activities.
- 3. This release will extend to any accidents, damages or claims whether arising out of my own acts or the acts of my horse within my control or the acts of others which have resulted in injury and/or death to me, my guests, my family members, agents or invitees.

I AM AWARE THAT RIDING IS A HAZARDOUS ACTIVITY AND I AM VOLUNTARILY PARTICIPATING IN THE ACTIVITY WITH THE KNOWLEDGE OF THE DANGER INVOLVED AND HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY AND/OR DEATH. I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS AGREEMENT IS A RELEASE OF LIABILITY AND CONTRACT BETWEEN MYSELF AND ARLENE OMELCHUK AND THREE HILLS RANCH / DOUG AND LYNETTE MILLS AND ERIN VALLEY RIDING STABLES AND THEIR EMPLOYEES, AGENTS, VOLUNTEERS, AND REPRESENTATIVES AND SIGN IT OF MY OWN FREE WILL.

I hereby release the Western Canadian Reining Association (WCRA) and the WCRA Kamloops Chapter and its volunteers or any representatives of the aforementioned, from any loss or damage that may occur, and it shall be the condition of entry that each exhibitor shall hold the Fun in the Sun Management blameless of any loss or accident to his/her horse or horse's equipment, and accident or injury that may happen to the rider/handler or any horse during this event. All owners and exhibitors shall be held responsible for any damage incurred by them or their agents to barns or properties on the show grounds and will be billed accordingly.
